

1.	Name of service	Adjustment of licence to engage in wholesale trade in beer, beer blends with non-alcoholic beverages, naturally fermented cider of not more than 8,5 per cent ethyl alcohol by volume (hereinafter referred to as "the licence")
2.	Recipients of service	Undertaking which holds a licence.

4.	Timeframe of service	The licence shall be adjusted not later than within 3 working days from the date of submitting all properly executed documents required to adjust a licence. In case not all necessary documents have been submitted or the submitted documents have failed to comply with the set requirements, the term shall be calculated from the date of submitting all the documents (this term shall not cover the time over which the undertaking submits additional or adjusted documents).
5.	Fees of service	State fee for adjusting a licence – 86 Eur
6.	Cross-border payment measures and procedure	Beneficiary of the state fee – State Tax Inspectorate under the Ministry of Finance of the Republic of Lithuania, code 188659752, the fee shall be paid to the budget revenues collection account Payment code 5753.
7.	Description of process for obtaining a service	1. An undertaking shall pay a state fee of the set amount and shall submit an application and required documents. 2. The Drug, Tobacco and Alcohol Control Department (hereinafter referred to as "the Department") shall handle the application. 3. The Department shall take a decision to adjust a licence. 4. The licence for an undertaking shall be adjusted using Licences Information System .
8.	List of documents to be submitted to obtain a service	1. When it is requested to delete addresses of warehouses from which wholesale in alcoholic beverages carried out and/or in which these beverages stored, it shall be required to submit: – application. 2. In cases of changes of particulars of the licence held by the undertaking which do not directly depend on the undertaking and in

		cases when a licence holder is reorganized resulting in the change of the data indicated on the licence, it shall be required to submit: 1. Application. 2. Documents certifying the data that have been changed.
