In case not all, incorrectly filled in documents or incorrect data have been provided, the term shall be calculated from the date of receipt of all supplemented or adjusted documents). |
| 5. | Fees of service | State fee for issuance of the licence – 289 Eur |

The licence for an undertaking shall be issued using Licences Information System . |
