4.	Timeframe of service	The licence shall be issued not later than within 30 calendar days from the date of receipt of all properly executed documents required to issue a licence. In case not all, incorrectly filled in documents or incorrect data have been provided, the term shall be calculated from the date of receipt of all or supplemented (adjusted) documents.
5.	Fees of service	State fee for issuance of the licence – 289 Eur
6.	Cross-border payment measures and procedure	Beneficiary of the state fee – State Tax Inspectorate under the Ministry of Finance of the Republic of Lithuania, code 188659752, the fee shall be paid to the budget revenues collection account Payment code 5753.
7.	Description of process for obtaining a service	An undertaking shall pay a state fee of the set amount and shall submit an application and required documents. 2. The Drug, Tobacco and Alcohol Control Department (hereinafter referred to as "the Department") shall handle the application. 3. The Department shall take a decision to issue a licence. 4. The licence for an undertaking shall be issued using Licences Information System .
