4.	Timeframe of service	The licence shall be issued not later than within 30 calendar days from the date of receipt of properly executed documents. In case not all documents have been provided the term shall be calculated from the date on which all documents have been submitted.

7.	Description of process for obtaining a service	1. An undertaking shall pay a state fee of the set amount and shall submit an application and required documents. 2. The Drug, Tobacco and Alcohol Control Department (hereinafter referred to as "the Department") shall handle the application. 3. The Department shall take a decision to issue a licence. 4. The licence for an undertaking shall be issued using Licences Information System .

		<p>State Food and Veterinary Service for the staff of the undertakings producing alcoholic products.</p> <p>3. Undertakings producing up to 5000 hectolitres of beer per year and having no possibility to equip their own laboratory shall submit a copy of the agreement on alcoholic products quality analysis concluded with another institution's or undertaking's alimentary products quality analysis laboratory approved according to the established procedure.</p> <p><u>Important:</u> an undertaking must hold an Approval Certificate of Food Business Operator issued by State Food and Veterinary Service (not required to be provided to the Department); approved normative documents which set out safety and quality indicators of the produced or intended to be produced products conforming with safety and quality indicators set and applied for alcoholic products; documents whereby it is approved that the equipment of the undertaking conforms with technological requirements; a certificate issued by SFVS on the approval carried out by alcoholic products quality analysis laboratory under established procedure (this certificate shall not be required if an undertaking produces up to 5000 hectolitres of beer).</p>
