4 ·	Timeframe of service	Decision to adjust or refuse to adjust a permit shall be taken and the permit shall be adjusted or the economic entity shall be notified of the decision not to adjust a permit not later than within 5 working days from the date of receipt of all properly executed documents that are needed to supplement the permit.
5.	Fees of service	State fee shall be: - for the adjustment of the permit to purchase non-denatured ethyl alcohol – 14 Eur; - for the adjustment of the permit to purchase and use denatured ethyl alcohol – 18 Eur; - for the adjustment of the permit to use denatured ethyl alcohol – 18 Eur
