Timeframe of service	Decision on issuance of the permit shall be taken not later than within 30 days from the date of receipt by the Department of the application and all documents required to issue a permit. In case of providing not all the documents, not completely filled in documents, documents failing to comply with the set requirements or incorrect data the term shall be calculated from the date on which all or supplemented (adjusted) documents have been received.

The Drug, Tobacco and Alcohol Control Department (hereinafter referred to as "the Department") shall handle the application.</p> <p>3. The Department shall take a decision to issue a permit.</p> <p>4. The permit for a legal person shall be issued using <a href="#">Licences Information System</a>.</p>
