4.	Timeframe of service	The licence shall be issued not later than within 30 calendar days from the date of receipt of all properly executed documents required to issue a licence. In case of providing not all necessary documents, incorrectly filled in or inaccurate documents the term shall be calculated from the date on which all or supplemented (adjusted) documents have been received.

The Drug, Tobacco and Alcohol Control Department (hereinafter referred to as "the Department") shall handle the application. 3. The Department shall take a decision to issue a licence. 4. The licence for an undertaking shall be issued using Licences Information System.
